### **Genealogy Corner: Alton Prison**

Do you have Confederate ancestors that disappeared during the Civil War? The history of Alton Prison may be of interest to you. Alton Prison originally opened in 1833 as the first Illinois State Penitentiary and then closed in 1860 when prisoners were moved to a new prison in Joliet. As the need arose for a place to house Confederate prisoners, the facility was deemed habitable and reopened, with the first prisoners arriving on February 9, 1862. It closed in 1865 when inmates were either released or transferred to St. Louis.

During the three years the prison operated, 11,764 Confederate prisoners passed through the gates. Confederate soldiers comprised most of the inmates but citizens convicted of treasonable acts and bushwhackers or those committing acts against the government were also incarcerated there.

Conditions at the prisoner were deplorable. Cold Midwest winters and hot, humid summers caused an above-average morality rate among those weakened by their poor diets and inadequate clothing for the local environment. Pneumonia, dysentery, smallpox and measles swept through the prison. A smallpox epidemic raged in the winter of 1862 and a quarantine hospital was located on an island across the river from the prison. Three hundred prisoners died and were buried on the island, which is now under water. A cemetery in North Alton was used for the majority of the other prisoners who passed.

The site www.altonweb.com/history/civilwar/confed/ has a data base of those who died at Alton Prison. It contains name, rank, company, state, date of capture, place of capture, date of death, cause of death and place of burial. Fourteen states of origin are represented here and just might answer the question of what happened to your ancestor.

An interesting site to check out for Scottish research is www.dustydoc.com. It is a link to free websites in Scotland containing parish records. And you will find some interesting records at www.scottishindexes.com.

Steve Morse is constantly updating his website <a href="www.stevemorese.org">www.stevemorese.org</a> and is worth reviewing on a regular basis. Useful sites/categories to access from Steve's site that may be of help to you in research are: Changed Street Names, Determining Counties, Relationship Calculator, Ahnentafel Calculator, "When did?" Calendar, Genetic Genealogy, and Latitude/Longitude (which converts address to/from latitude/longitude/altitude.)

# Reverend William Johnston – The Man Who Prevented the Last Indian War

The Navajo first met the white man in the late 1500s when the Spanish rode north into the Southwest. From then onward it was mostly strife, with the Spanish and then Mexicans taking Indian food, livestock, land and eventually raiding for slaves to work the farms and mines. After the Mexican War, there were new white men who also coveted Navajo lands. When the Civil War started, the whites were busy fighting each other and the Indians took advantage, raiding their former lands. They were met by the New Mexico Militia and Union Army.

In 1863, the U.S. Government sent Col. Kit Carson, the famous trapper and guide, to bring the Navajo and Apaches onto the reservations, and by 1864 eight thousand Navajo walked three hundred miles to a reservation at Fort Sumner, NM. One elder commented on the *Long Walk*, "I have never been able to understand a people who killed you one day and on the next played with your children." This was one of the many cultural differences between the two nations.

In 1868 the U.S. and Navajos signed a peace treaty; the Indians were allowed to return to their old reservation northeast of Flagstaff, AZ where they continued their ranching and farming but often had run-ins with white ranchers moving into the area. The Long Walk was still fresh on their minds, but they had promised to obey the laws and not gather in armed revolt against the whites and a Navajo's word was his bond.

In 1884; Bill Rodens, a Texas cattleman arrived with two hundred head of cattle and started grazing on public domain land. It was not part of the reservation but Navajos had grazed there for centuries and there were springs in a dry area. Tribal Leader Biwoo Adini, who had been on the Long Walk, rebuilt his herd of sheep, goats, horses and cattle there each summer. The Texan would not rest, however, until the Indians were gone from the land he said belonged to the whites who had settled it.

Roden filed charges in 1891 against Adini for horse theft but the Indian Agent was very suspicious, knowing the integrity of the Adini family. He hired a lawyer for the Navajo, who investigated and proved in court that the charges were trumped up and Adini was acquitted. Then in 1899 Adini led five relatives on a deer hunt to Padre Canyon, 35 miles southeast of Flagstaff. During one night two tethered Navajo ponies wandered away. The next day two of the hunters tracked them and encountered one of the cowboys, William Montgomery. Montgomery accused the Indians of stealing his horses and the Indians beat him up for stealing theirs, as was the custom of Indians who caught whites rustling livestock.

Mongomery returned to town and filed charges with the sheriff, who promptly wrote out a warrant for assault with deadly

weapons and sent a deputy to form a posse of Bill Roden, Jr., Montgomery, and another of his cowboys. When the two hunters returned to their camp without the lost ponies, Adini knew that trouble was likely so he convinced the band to ride back to the reservation the next day. They hadn't left the camp when the four posse members rode in. The whites drew their sidearms and the deputy announced that he had a warrant for the arrest of the two Navajo but none of them could speak English and only understood that they were looking down the barrels of four revolvers. When the whites tried to collect the Indian rifles, Adini's men scuffled with them and gunfire erupted. Mongomery was killed along with two Indians and Adini was severely wounded; the surviving Navajo fled into the mountains.



Immediately, most of the whites in Arizona took to arms. Eleven years after the Battle of Wounded Knee in which the

army had killed peaceful Sioux, the Indians on the reservation --fearing another invasion and a *Long Walk* -- gathered their firearms. Fifteen riders from Flagstaff immediately pursued the Adini band and Arizona became a powder keg.

As luck would have it, a Methodist missionary, William Johnston, was riding back to his home on the reservation along the Little Colorado River. At the seriously wounded Adini's hogan, he found a large band of armed Indians preparing for conflict. Johnston and Adini discussed how to remedy this situation. Because Johnston had great standing in both cultures, he offered to mediate and the Indians agreed.

Johnston rode back to Flagstaff and convinced the sheriff not to send another posse into Navajo lands while he worked to convince Adini and his band to appear in court. Going back to the Indians, he persuaded them of just that. The Reverend promised that he would get them the best lawyer; he pointed out that Adini had been acquitted in 1891 by a jury for horse stealing, and most importantly he reminded them of the Treaty of 1868 in which they had promised to obey the laws and not to gather in armed rebellion. That was the deciding factor, for no honorable Navajo could violate his pledge without great provocation.

That spring of 1900 saw the gravely wounded seventy-year-old Biwoo Adini ride his horse 150 miles to appear at trial. He arrived late due to his condition but made a dramatic entrance the last day of trial. After all, he had given his word to Johnston that he would appear, if he lived.

The Indians were defended by the U.S. District Attorney and an Indian Rights lawyer from Philadelphia. The only witnesses for the Indian side were the two accused and they spoke no English. No one else spoke Navajo, except nine-year-old Philip Johnston, the minister's son, who had learned the language playing with the Indian children on the reservation. His translation of one of the men's articulate description of the events was so compelling that the lumbermen and ranchers of the jury in three hours found all three not guilty! The local paper also praised the U.S. Attorney for his fine defense.

Johnston reasoned that unless this joint land controversy were settled, it was likely that cowboys and Indians would clash again. He arranged a meeting with President Theodore Roosevelt to expand the reservation as that was essential to the well-being of the tribe. These traditional hunting and grazing lands had to be formalized as Navajo.

Johnston travelled to Washington with Philip and two tribal leaders who argued that the tribe had lived on this land since before the coming of the Spanish and that this land was absolutely essential to the well-being of the Navajo People. As in the courtroom, little Philip translated the petitions to the President of the United States. After the meeting, Roosevelt issued the executive order which set aside the disputed lands for the expansion of the Navajo Reservation.

William Johnston was granted a new mission on the reservation for his service and Philip went on to serve in the army in WWI, get an engineering degree, and work for the City of Los Angeles up until WWII. Philip then made his biggest contribution to our nation. As one of only ten whites who could speak Navajo, he convinced the Marines to set up the Code Talker program where 450 Navajo Marines spoke in a native code on the radios. Even untrained Navajo had no idea what they were saying, let alone the Japanese code breakers. Thousands of Marines and sailors were saved by this secure and accurate communication from the Navajo reservation of Arizona.

# **CJA Strategic Plan for 2017**

The Strategic Planning Committee is pleased to present the CJA Strategic Plan for 2017. This is illustrated in the Strategic Framework chart shown on the next page. Changes have been made based on CJA Council and member input, including those in attendance at last year's 2016 AGM at Stone Mountain GA.

This year we have updated the "Mission" and "Vision" statements to broaden their scope, and bring them more into alignment with Article III of the CJA Bylaws.

Other highlights for 2017 include:

<u>Formation of a Genealogy Committee</u>. This group will begin the process of exploring our CJA database of member family trees in order to make them more accessible for member research. The goal will be to post much of this information on a private section of our website with access for members only. Current member contact information will also be posted in the private section of the website.

The Social Media Committee led by Seth Johnson will be creating the member-only section of the CJA website. In addition the SMC will be exploring more e-commerce functionality for paying dues, and presenting and purchasing CJA merchandise. This group will also work closely with the Genealogy Committee for technical support

<u>The Membership Committee</u> (formerly Tent Hosting) led by Valerie Ensor will be expanding recruitment efforts for new members with the assistance of State and Provincial Commissioners. They will also be introducing new incentives for tent hosting, as well as new member sign-ups. The Membership Committee will also be asking past tent hosts to donate their hosting banners and materials so that new tent hosts can use them.

<u>The Bylaws Committee</u> led by Valerie Ensor has been formed to review and propose updates to the Bylaws for Council approval.

<u>A "Call for Volunteers"</u> will be introduced to attract members to CJA committees as well as co-chair CJA Council positions. The first version can be found in this edition of the Spur & Phoenix. This document will be updated regularly and posted on the CJA website and Facebook page.

In order to achieve our Strategic Goals, we urge everyone to volunteer and support our Clan!

# Call for Volunteers!

As a member-driven organization, Clan Johnston/e in America and Canada is only as strong as its member support. We are currently looking for member-volunteers to fill the following positions. Most positions take less than an hour a month, with meetings typically held using "Skype".

POSITION	DESCRIPTION
Co-Chair Council Positions:	
Co-Chair Membership	Assist the National Membership Commissioner in recruiting new members, and coordinating our Clan representation (Tent Hosts) at various games and festivals across the countries.
Co-Chair Registrar	Assist the Registrar in maintaining membership records, and processing annual renewals and dues. This includes notifying the members regarding renewals and issuing membership cards.
Co-Chair Treasurer	Assist the Treasurer in keeping correct and complete books and records of all accounts. The Treasurer also manages banking, investments, and the Clan's annual budget, as well as preparing the annual financial report, and non-profit tax submissions.
Co-Chair Secretary	Assist the Secretary in keeping records for all Clan proceedings, and conducting official correspondence as directed by the President and Council. This includes preparing the Annual General Meeting information package.
Co-Chair Genealogist	Assist the Clan Genealogist in maintaining and making available archival materials and genealogical information, as well as helping members achieve accuracy and good documentation in their genealogical research.
Co-Chair Editor	Assist the Editor in editing, publishing, and mailing the quarterly Spur & Phoenix newsletter.
Committee Members:	
Nominating Committee	The Nominating Committee meets annually to review and approve nominees for election of pending Council positions.
Membership Committee	The Membership Committee meets quarterly or as needed to devise policies and methods for recruiting new members, subject to Council approval. They also manage the coverage of Tent Hosts at various games and festivals, working with the State/ Provincial Commissioners.
Social Media Committee	The Social Media Committee meets quarterly or as needed to manage Clan information across our web, Facebook, and print platforms. They are also responsible for developing and managing platforms.
Genealogy Committee	The Genealogy Committee meets quarterly or as needed to manage member genealogical information and archives, and add them to our database, as well as respond to member inquiries. They also prepare articles for the Spur & Phoenix newsletter promoting accuracy and good documentation in genealogical research.
Tent Hosting Members:
